**Nature of the data processed:** We process personal data and data that are necessary for carrying out the relationship with users. The data marked with an asterisk are indispensable for carrying out the relationship with the users.

**Processing methods:** The data processing takes place through the use of tools and procedures that guarantee security and confidentiality and can be carried out using paper and/or computerized supports.

**Purpose of the processing:** Your data will be processed exclusively to achieve the purposes of the service connected to the sale of season tickets to travel on our buses, unless you expressly authorize us to use them for sending information and commercial promotions aimed at informing about new products / services of the Company, modifications of the same, suspensions, reinstatements, modifications of routes and/or of the service, in paper form, by e-mail messages, messages on mobile phones. Your data will not be disclosed to third parties and will only be made available to the competent authorities and in the presence of adequate authorizations. The data will be processed for the entire duration of the contractual relationship and also subsequently for the fulfillment of legal obligations and for administrative and commercial purposes.
